*Substitutes who have worked a minimum of 30 days in a school year may be eligible for 24 hours of sick leave after the $90^{\text {th }}$ day of employment.
**The hourly rate of pay for an individual working as a classified substitute, or in a temporary classified position, shall be equal to the first step on the salary schedule for that job classification when the individual works for eleven (11) consecutive days or more in the same position. The individual will be paid at this rate retroactively from the first day of the assignment.
