RESOLUTION NO. 016-24/25

Authorizing the Sale of Surplus Equipment

WHEREAS, the Livermore Valley Joint Unified School District Board of Education is authorized under the provisions of Education Code Section 17545 to sell for cash any surplus property belonging to the School District if the property is not required for school purposes, and under the provisions of Education Code Section 17546 "any item or items of property having previously been offered for sale pursuant to Section 17545 may be disposed of in the local public dump if those items are unable to be sold at auction and have no value to the District;" and

WHEREAS, there shall be no sale until notice of the sale has been posted in three public places in the District for not less than two weeks, or by publication for at least once a week for a period of not less than two weeks in a newspaper published in the District and/or having a general circulation there; and

WHEREAS, the Board shall sell the surplus property to the highest responsible bidder, or shall reject all bids; and

WHEREAS, the Board finds there are certain surplus property items no longer required for school purposes and that should be disposed of.

NOW, THEREFORE, BE IT RESOLVED that the Board reserves the right to withdraw any or all items from the sale.
